REMEMBER!

1) You are NOT allowed to throw candy from the floats per City of Chinook Ordinances.

Handing out candy to the kids along the street is acceptable ONLY if you are WALKING NEXT TO THE CURB!

2) You must possess a VALID Driver's License to drive in the Parade.

3) Absolutely NO driving under the influence of drugs or alcohol is tolerated. You will be asked to leave.

IMPORTANT INFORMATION:

Please keep the parade close together but not too close – keep a safe distance behind the entry in front of you. Gaps create unsafe situations. We would like to take this time to thank all of the participants that helped make the Parade of Lights a success and we look forward to seeing you next year.

Please Remember – this is a fun event and we always have a great turnout, but please be patient with the organizers, we encourage your input as ways to better our parade at any Chamber of Commerce regular meeting.

Release of Liability
